ENTRY FEE-NONE, BUT RIVERFEST BUTTON REQUIRED FOR THOSE AGED
13 AND OVER

1. Any AMATEUR is eligible to enter. If you have been PAID, you are not an amateur.
2. Entry forms available at www.riverfestlacrosse.com, every entrant (even if a group act) must fill out a signed entry form (if under 18 yrs of age, must be signed by a parent or legal guardian) **ENTRY DEADLINE: MONDAY JUNE 27TH, 2011.**
3. There are 3 age categories: Categories may change depending on number of entrants. Groups to be divided as evenly as possible. Tentative age groups 1.) 9 yrs & younger, 2.) 10 – 13 yrs, 3.) 14 yrs & older.
4. Lip Sync contest will be judged by a panel of 4 judges. **Highest scores decide cash winners.**
Contest judged on 1.) Lip-Sync ability, 2.)Authenticity or Originality, 3.) Appearance
Each category has a possible high point of 10, so each judge could give a possible 40 points per performance.
5. CASH will be awarded as followed. Each age category will be awarded three cash prizes: 1st - \$500, 2nd - \$300, 3rd \$200. There are a limited number of entries. Positions filled on first come-first serve basis.
6. People’s Choice Award voting at Finals event will be announced at event that day. Applause meter to be used.
7. **VERY IMPORTANT:** Entrants must provide a CD of their music selection edited to 2 ½ minutes or less – NO MORE. Burn your own CD for the competition. The only selection on the CD must be your edited version. Mark your CD clearly with your name and music selection. You must also have a back-up tape or CD available in case of malfunction.
8. Pre-registration required: Each entrant or group will be notified via phone call, confirming their performance date... Come dressed ready to perform.

All contestants age 13 and over are REQUIRED TO HAVE A RIVERFEST BUTTON TO ENTER RIVERFEST GROUNDS.

Button cost is \$5 prior to Festival, and \$7 at the gate.

I have volunteered to participate without compensation in the “Puttin on the Lips” lip-sync contest. In connection therewith, I hereby represent, warrant and grant as follows,

1. I hereby grant to the sponsors and or the producers of the Contest, any program produced in connection therewith (the program) the right to photograph, record and otherwise reproduce in any manner whatsoever my performance, appearance, photographs, likeness, name, voice, statement, musical and any other sound or visual effects produced by me (my appearance) and the rights to use my appearance e in any manner, in perpetuity, worldwide in any media by any means now known or later developed incorporating part or all that I say or do on the contest. My appearance can be edited, eliminated, rearranged or changed or added to other material without payment to me of any compensation thereof. It is understood that you are not obligated to broadcast or use any videotape, film or other recording of the contest of which I am entering. I understand and agree that your selecting me as a participant is within your sole discretion irrespective of any test I may have taken and that you are under no obligation to me whatsoever.
